Jewish Genealogical Society of Los Angeles -Exhibitor Agreement

The Hotel will not be responsible or liable for any loss, damage or claims arising out of exhibitor's activities on the Hotel premises except for any claims, loss or damages arising directly from its negligence. In the event that, because of fire, strike, government regulation, public catastrophe, act of God, etc. beyond the control of management, the Exhibit Show is not held, JGSLA will refund that portion of monies received which remains after deducting expenses and reasonable compensation. However, in no case shall the reimbursement exceed the amount of the exhibit fee paid. No exhibitor shall assign or sublet part of the space allotted without the specific consent of JGSLA.

The exhibitor agrees to indemnify and to hold harmless JGSLA for any damage, loss, harm, or injury to the person or property of the exhibitor caused by the exhibitor, his agents, representatives, or any other person. It is the sole responsibility of the exhibitor to obtain the proper insurance covering such losses and indemnification by the exhibitor.

Exhibitor is responsible for damage to his leased space. No signs or other articles may be affixed, nailed, or otherwise attached to walls, doors, windows, etc. in such a manner as to deface or damage them. Likewise, no attachments may be made to the floors by nails, screws, tape or other devices.

Once an exhibitor contract is approved, the exhibitor name and URL will be listed on the conference website.

Exhibitors will receive a complimentary business card size advertisement in the conference banquet booklet.

All exhibitors are responsible for making their own arrangements for electrical service with the hotel.

All Exhibitors are responsible for shipping, delivery, receipt, and storage of their items to be used in the Exhibit Show, including empty crates and shipping materials.

Exhibitors may not distribute, solicit, or sell items outside the exhibitor area.

Exhibitors and their agent(s) shall conduct themselves in a professional and ethical manner at all times during the conference. Ethical conduct for Exhibitor and agent(s) excludes all illegal activities and the promulgation of erroneous or misleading information about products and services they are selling or about products or services sold by others. Any Exhibitor or agents found to be involved in illegal activities or to be passing false or misleading information may result in the Exhibitor being ejected from the conference at the discretion of the Conference Chairs.

Assignment of space will be made by JGSLA and may be changed at any time, including during a conference, for any reason, stated or unstated, by the Exhibitor Chair. Chairs, furniture, or other materials shall not be placed outside the assigned space or set up in such a manner as to block exits, access to other rooms, or access to other Exhibitor's space.

Exhibitor agrees to cooperate with the JGSLA Conference staff.

Payment for table(s) must be made at the time the table(s) are reserved.

The JGSLA will provide guard service through the closed hours of installation, show and dismantling.

Each Exhibitor agrees that he and his agents will abide by these regulations and by subsequent amendments and additions thereto, it being fully understood and agreed that the sole control of the Exhibit Area and Conference space rests with JGSLA.

This agreement must be signed before any Exhibitor may set up in the Exhibit Area.
